All surfaces to be coated must be clean, dry and free from contamination. High pressure fresh water wash or fresh water wash, as appropriate, and remove all oil or grease, soluble contaminants and other foreign matter in accordance with SSPC-SP1 solvent cleaning.

Bare Steel Abrasive blast clean to Sa21/2(ISO 8501-1:2007). Power tool cleaning to min. St2(ISO

8501-1:2007) may be acceptable, subject to exposure conditions.

Shop Primer Approved shop primers must be clean, dry and free from soluble salts and any other surface

contaminants. Unapproved shop primers will require complete removal by blast cleaning to

Sa2½ (ISO 8501-1:2007). Consult Hilong representative for specific recommendations. Abrasive blast clean to Sa2 (ISO 8501-1:2007). Power tool cleaning to min. St2(ISO

8501–1:2007) may be acceptable, subject to exposure conditions.

ApplicationCondition The temperature of the substrate should be minimum 5°C and at least 3°C above the dew point

of the air. Good ventilation is required in confined areas to ensure proper drying. During application and the initial drying of the coating, the coating should not be exposed to high

humidity as this can result in loss of gloss.

Mixing Combine 4 parts of Base with 1 part of Curing Agent and mix thoroughly with power agitator.
